- (ii) Brigadier or equivalent with three years regular service in the rank; and
- (iii) possessing a Bachelor degree in Civil / Mechanical / Electrical Engineering and fifteen years of experience in planning / construction / design / maintenance in Civil and Technical/Industrial structures / Estate Management and Contract Management.


**Note-1:** The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment on promotion.

**Note-2:** Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed five years.

**Note-3:** The maximum age limit for appointment on deputation shall be not exceeding fifty-eight years as on the closing date of the receipt of the application.

**Note-4:** Field experience of minimum three years in execution / project management of major project at site.
